Patricia A. Labarthe, of lawful age, being first duly sworn deposes and says:


1. I am an Enforcement Attorney for the Oklahoma Department of Securities.
2. On August 2, 2004, I prepared and filed in the District Court of Oklahoma County, State of Oklahoma, a Petition for Permanent Injunction and Other Equitable Relief (Petition) and Application for Temporary Restraining Order, Asset Freeze and Temporary Injunction and Brief in Support (Application), against Sojkara, L.L.C. a/k/a Sojkara ISP India

L.L.C. (Sojkara). On August 2, 2004, this Court issued a Temporary Restraining Order, Order Freezing Assets and Order for Accounting (TRO) against Sojkara. Sojkara is a Michigan limited liability company and has no registered agent listed in the records of the Oklahoma Secretary of State.

3. On August 2, 2004, I mailed a summons with a copy of the Petition, application, and TRO to Plaintiff's last known address for Sojkara at 2375 Traversefield Drive, Traverse City, Michigan 49686. On August 10, 2004, the mailing was returned to me by the United States Postal Service marked "Returned to Sender, Not Deliverable As Addressed, Unable to Forward."

4. On July 11, 2005, I served on the Oklahoma Secretary of State, an alias summons with a copy of the Petition, application, and TRO. I also provided the Oklahoma Secretary of State with a certified copy of the return showing the attempted service at the Traverse City, Michigan address.


