

MOTION TO INTERVENE


COMES NOW The Bank of Union, and in support of its Motion to Intervene, states as follows:

1. The Bank of Union (“the Bank”), and its officers and directors, have been the subject of harassment and abuse by the Respondents and their counsel through various discovery tactics.
2. The Bank has been informed by Respondents’ counsel that Respondents will yet again attempt to obtain subpoenas from the Department for certain directors and shareholders of the Bank, including Mr. Timothy Headington.
3. The Bank hereby respectfully requests that it be allowed to intervene for the limited purpose of opposing any such request by Respondents for such subpoenas and to be heard by the Hearing Officer prior to the issuance of such subpoenas.
4. If allowed to intervene as requested, the Bank believes the prudent course would be to establish a briefing schedule to allow it to present its arguments in writing to the Hearing Officer prior to the issuance of any subpoenas requested by Respondents.

WHEREFORE, the Bank respectfully requests that it be allowed to intervene in this matter for the limited purpose set forth above, and for such other relief the Hearing Officer deems prudent under the circumstances.
