**MOTION TO DISALLOW INVESTOR CLAIM DESIGNATION
 AND PARTIAL DISTRIBUTION TO INVESTOR**

On October 4, 2007, this Court issued an order approving investor claim designations and a partial distribution to investors, upon the motion of the Oklahoma Department of Securities *ex rel.* Irving L. Faught, Administrator (“Plaintiff”). It has now come to the attention of the Plaintiff that a check for \$200.00 sent to Defendant Raglin Industries, LLC (Defendant), from claimant number 186 (Investor 186), was never negotiated. Investor 186 never presented evidence of any additional investment with Defendant. A partial distribution to Investor 186 would constitute unjust enrichment. Plaintiff respectfully moves for an order reducing the designation of claim amount for Investor 186 to \$0, and disallowing a distribution of funds to Investor 186.
