**REPORT OF OKLAHOMA DEPARTMENT OF SECURITIES AND
MOTION FOR APPROVAL OF INVESTOR CLAIM DESIGNATIONS
AND PARTIAL DISTRIBUTION TO INVESTORS**

The Oklahoma Department of Securities *ex rel.* Irving L. Faught, Administrator (“Plaintiff”), submits its report to the Court regarding claims received pursuant to the order of this Court from those persons (Investors) who invested money with Defendants Raglin Industries, LLC, Phillip Levaughn Raglin and Joseph Daniel Layne (collectively, “Defendants”). Plaintiff also respectfully moves for an order approving the designation of Investor claim amounts by Plaintiff and authorizing a partial distribution of funds to Investors who can substantiate a claim for such distribution.

On March 1, 2007, Plaintiff requested and on March 2, 2007, this Court entered an order establishing a claims procedure to notify Investors that they are required to submit a proof of claim setting forth the nature and amount of their investments and to provide documentation of such amounts. Claims were required to be submitted to Plaintiff on or before April 5, 2007. Plaintiff mailed a Proof of Claim form to all Investors of Defendants, known to Plaintiff, by regular mail.

Plaintiff has completed a review of Investor Proof of Claim forms and supporting documentation. Plaintiff has compared this information with the Raglin Industries, LLC databases and bank records of Defendants. Plaintiff has prepared a report in which a claim number is assigned to each Investor for identification and a claim amount is designated to each Investor. See Exhibit A. Plaintiff has also prepared a letter notifying Investors of the claim amount Plaintiff has designated to them and of their opportunity to be heard on any disagreement with such designation. See Exhibit B.

Funds in the bank accounts of Raglin Industries LLC, at Bank of America and JP Morgan Chase, should be paid as restitution to Investors whose claims are approved by this Court.

Plaintiff respectfully requests that this Court approve the claim amounts designated by Plaintiff according to the report attached as Exhibit A. Plaintiff also requests that this Court approve a partial distribution to Investors on a pro rata basis based on the designated claim amounts.


