ORDER

The Parties come now on Defendant's Application for Order Regarding Disbursement of Necessary Expenses and Reasonable Attorney's Fees for Defendant with the Court's Approval, and the Court, having heard arguments from both sides, orders the following disbursements be made:

1. Thirty Six Thousand Three Hundred Sixty Eight Dollars and No Cents (\$36,368.00), minus five percent (5%) if paid up front, made payable to Talbott Recovery Center;
2. ~~Thirty Thousand Dollars~~ and No Cents (^{FIFTEEN THOUSAND DOLLARS 15,000.00} \$30,000.00) made payable to Josh Welch;
3. One Thousand Five Hundred Dollars and No Cents (\$1,500.00) made payable to Jerry Cash for miscellaneous expenses while living at Talbott Recovery Center;
4. Eight Hundred Fifty Dollars and No Cents (\$850.00) made payable to Jerry Cash for airfare reimbursement.

It is further Ordered that these checks be disbursed on today's date, and the Court makes a specific finding that the Attorney's fees are reasonable and Defendant's need for treatment is a necessary living expense pursuant to the Temporary Injunction and Order Freezing Assets filed August 29, 2008.
