AGREED ORDER TO RELEASE ASSET FREEZE
AGAINST TWO BANK ACCOUNTS
OF DEFENDANT FARNHAM

The Oklahoma Department of Securities (Department) agrees to modify the Court's Temporary Restraining Order, Order Freezing Assets, and Order for Accounting entered March 24, 2009 (Order).

Defendant Farnham has requested a partial release of his assets frozen by the Order, to wit, account ending 7192 at Bank of America and account ending 9813 at Weokie Credit Union. The Department agrees to the release of these frozen assets in reliance upon representations that the accounts have minimum and/or negative balances and are the only bank accounts of Defendant Farnham.

IT IS HEREBY ORDERED that the following two bank accounts of Defendant Farnham shall be released from the asset freeze:

1. Bank of America account ending 7192; and
2. Weokie Credit Union account ending 9813.

All other aspects of the Order shall remain in effect with respect to Defendant Farnham.


