**INTERIM APPLICATION OF  
SPECIAL MASTER, STEPHEN J. MORIARTY  
FOR COMPENSATION AND REIMBURSEMENT OF EXPENSES**

COMES NOW, Stephen J. Moriarty (“Special Master”), the Court appointed receiver for Global West Funding, Global West Financial LLC, Sure Lock Loans, LLC, The Wave-Goldmade, Ltd., and Brian McKye (collectively referred to as the “McKye Companies”), and for his first application for compensation and reimbursement of expenses, alleges and states as follows:

1. April 1, 2009, this Court entered its order appointing the Special Master (The "Order:"). Pursuant to the Order, the Special Master was given "immediate and exclusive custody, control and possession of all assets . . . of Defendants, of whatever kind and description, and wherever situated." Further, Special Master was given the authority "to take the necessary steps to protect the interests of Investors, including the liquidation or sale of assets of Defendants. . . ."

2. Pursuant to the Order, "the Special Master may apply to the Court for compensation from time to time, in a reasonable sum to be determined by the Court and from such sources as approved by the Court and for reimbursement of reasonable expenses incurred with his duties as Special Master."

3. Special Master seeks interim compensation at his normal hourly rate for work performed, plus reimbursement of Special Master's actual and necessary expenses, for the period April 1, 2009 through June 30, 2009.

4. The amount of compensation to be allowed rests within the sound discretion of the Court. Hudson v. Hubbell, 1935 OK 138, 41 P.2d 844.


5. Special Master has devoted substantial time and effort in the execution of his duties and seeks compensation as detailed in the statement attached as Exhibit "A." The charges set forth in Exhibit "A" were reasonable and necessary.

6. Due to the extensive time required to discharge his duties, Special Master has been forced to decline other legal representations.

7. This Application covers allowance of compensation and reimbursement of expenses for the period of April 1, 2009 through June 30, 2009. During the period covered by this application, Special Master expended a total of 250.2 hours at a hourly rate of \$325.00. Other attorneys and

paralegals have billed a total of 43.5 hours at hourly rates between \$100 - \$160 per hour. In addition, Special Master seeks reimbursement of expenses in the amount of \$1,276.32, as detailed in Exhibit "B" hereto.

WHEREFORE, Special Master respectfully requests that this Court enter an Order approving interim compensation to Special Master in the amount of \$87,600.00 and reimbursement of expenses in the amount of \$1,376.32, for the period April 1, 2009 through June 30, 2009.
