PLAINTIFF'S MOTION TO RESCHEDULE PRETRIAL CONFERENCE


Plaintiff, Oklahoma Department of Securities, hereby requests that the Court reschedule the Pretrial Conference of this case, for the following reasons:

1. Plaintiff appeared on September 24, 2009, for its Motion to Enter with regard to Defendants Brian McKye, Joe Don Johnson, and Heritage Estate Service LLC (collectively, "Defendants"). Defendants did not appear.
2. A Scheduling Order was issued on September 24, 2009, and the Pretrial Conference (Pretrial) for this case was scheduled for November 10, 2009, at 10:00 a.m.
3. On the date the Scheduling Order was issued, certain deadlines established in the order had already passed as follows:
 - a. the exchange of preliminary witness/exhibit lists was required to be made sixty (60) days prior to the date of the Pretrial; and
 - b. the filing of dispositive motions was required to be made sixty (60) days prior to the date of the Pretrial.

4. On October 5, 2009, this Court issued an Order Allowing Withdrawal on the motion of R. Scott Adams, as counsel for Defendants Joe Don Johnson and Heritage Estate Service, LLC. The Order Allowing Withdrawal provided Defendants Joe Don Johnson and Heritage Estate Service, LLC thirty (30) days to secure an entry of appearance by other counsel or to enter an appearance in his own name. The Order Allowing Withdrawal also stayed “all proceedings in this cause” for up to thirty (30) days.

Wherefore, Plaintiff requests this Court reschedule the Pretrial of this case to allow compliance with the Scheduling Order and the Order Allowing Withdrawal.
