**ORDER OF DISMISSAL AND DISCHARGE OF
THE SPECIAL MASTER**

On March 23, 2009, Plaintiff filed a *Petition for Permanent Injunction and other Equitable Relief* ("Petition") against the Defendants Global West Funding, Ltd., Co., Global West Financial LLC, Sure Lock Financial, LLC, Sure Lock Loans LLC, The Wave-Goldmade Ltd., Brian McKye, Joe Don Johnson, and James Farnham, pursuant to Section 1-603 of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§1-101 through 1-701 (Supp. 2003), and an application for order freezing assets. Heritage Estate Service LLC (Heritage) was named as a Relief Defendant.

On April 1, 2009, an Agreed Order Appointing Special Master was entered by this Court. Stephen J. Moriarty was appointed Special Master over Defendants Global West Funding, Ltd., Co., Global West Financial LLC, Sure Lock Financial, LLC, Sure Lock Loans, LLC, The Wave-Goldmade, Ltd., and Brian McKye.

On April 10, 2009, Plaintiff amended the Petition to include Heritage as a Defendant. On April 23, 2009, Stephen J. Moriarty was appointed Special Master over Heritage.

On March 27, 2012, Plaintiff filed a *Motion to Dismiss and to Discharge the Special Master* (Motion).

This Court, having reviewed all pleadings and submissions of the parties finds that the goals for which the Special Master was appointed have been successfully achieved, the purposes for which the Special Master was appointed have been fulfilled, and the need for continued oversight by the Special Master is now at an end.

IT IS THEREFORE ORDERED that all the actions taken by the Special Master in this matter were taken for the benefit of investors and other persons likely to have been injured by investment activities of Defendants Global West Funding, Ltd., Co., Global West Financial LLC, Sure Lock Financial, LLC, Sure Lock Loans LLC, The Wave-Goldmade Ltd., Brian McKye, and Heritage and are in accordance with the purposes for which the Special Master was appointed. This Court is satisfied that all payments made by the Special Master from the liquidation of Defendants' assets were legal and proper.

IT IS FURTHER ORDERED that the Special Master has taken reasonable actions necessary to settle all outstanding claims against the Defendants.

IT IS FURTHER ORDERED that attempts were made to serve Jeff Burke with a letter from the Special Master regarding the remand of his appeal to this Court and with the Plaintiff's *Motion to Dismiss and to Discharge the Special Master*. Jeff Burke has forfeited any claim against any of the Defendants or against the Special Master estate.

IT IS FURTHER ORDERED that the Special Master turn over all his books and records to the Oklahoma Department of Securities.

IT IS FURTHER ORDERED that the rights, powers and duties of the Special Master previously established by this Court are terminated and are hereby dissolved effective the date

hereof and the Special Master shall have no further obligations in this matter.

IT IS FURTHER ORDERED that all of the Special Master's actions in this case are hereby approved and the Special Master is hereby discharged.

IT IS FURTHER ORDERED that this case is dismissed.


