**FINAL ORDER, JUDGMENT AND PERMANENT INJUNCTION AGAINST
DEFENDANT MARK S. TRIMBLE**

On this 30 day of September, 2009, this matter came before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, for entry by consent of this *Final Order, Judgment and Permanent Injunction Against Defendant Mark S. Trimble* (“Order”). After a review of the pleadings and *Defendant Mark S. Trimble’s Stipulation and Consent to Final Order* (“Stipulation and Consent”), this Court finds:

On September 9, 2009, Plaintiff filed a petition alleging that Defendant Mark S. Trimble (“Trimble”) engaged in violations of the Oklahoma Uniform Securities Act of 2004 (“Act”), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2004), in connection with the offer and/or sale of securities in and/or from Oklahoma. Defendant Trimble executed the Stipulation and Consent attached hereto as “Exhibit A” and made a part hereof, without admitting or denying any allegations in Plaintiff’s petition, except as stipulated. Plaintiff has no objection to the terms of the Stipulation and Consent and agrees to the entry of this Order.

Based on the pleadings and execution of the Stipulation and Consent, this Order should be entered, and therefore:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Defendant Trimble is permanently enjoined from transacting business in and/or from the state of Oklahoma as an issuer, issuer agent, broker-dealer, broker-dealer agent, investment adviser, and/or investment adviser representative, as defined in the Act, or otherwise engaging in the offer and/or sale of securities in and/or from the state of Oklahoma.

IT IS FURTHER ORDERED that this Court will retain jurisdiction of this matter for the purpose of enforcement of this Order and the Stipulation and Consent.

Defendant, Mark S. Trimble ("Trimble"), hereby stipulates to the following:


1. Plaintiff is the proper party to bring this action seeking the relief requested in the *Petition for Permanent Injunction* ("Petition") filed in this matter.

2. Defendant Trimble is subject to the jurisdiction of this Court, and venue is proper in Oklahoma County.

3. Defendant Trimble enters this *Stipulation and Consent to Final Order* ("Stipulation and Consent") without admitting or denying any allegation in the Petition, except as stipulated above.

Defendant Trimble hereby undertakes as follows:

1. Defendant Trimble consents to the entry of the *Final Order, Judgment and Permanent Injunction against Defendant Mark S. Trimble* ("Order"), in the form attached hereto as "Exhibit A".



2. Defendant Trimble agrees not to transact business in and/or from the state of Oklahoma as an issuer, issuer agent, broker-dealer, broker-dealer agent, investment adviser, and/or investment adviser representative, as defined in the Act, or otherwise engage in the offer and/or sale of securities in and/or from the state of Oklahoma.

3. Defendant Trimble states that this Stipulation and Consent is entered into voluntarily and that no threat or promise of immunity of any kind has been made by the Administrator of the Oklahoma Department Securities, any employee of the Oklahoma Department of Securities, or any member of the Oklahoma Securities Commission, to induce Defendant Trimble to enter into this Stipulation and Consent.

4. Defendant Trimble agrees that the provisions of this Stipulation and Consent shall be incorporated by reference into the Order as though set forth in full therein.

5. Defendant Trimble waives any right to appeal the Order.


6. Defendant Trimble agrees that this Court will retain jurisdiction over this matter for the purpose of enforcement of the Order and this Stipulation and Consent.


