**JUDGMENT**

This action came before the Court on the motion of Plaintiff, Oklahoma Department of Securities *ex rel.* Irving L. Faught, Administrator, for default judgment against Defendant, Justin Wayne Baker.

The Court, having reviewed the Plaintiff's Petition for Permanent Injunction and Other Relief ("Petition"), summons, return of service and court file, finds that Defendant has been validly served with the Petition and summons; that the date by which Defendant was required to appear and defend this action was January 12, 2018; that no appearance has been made by Defendant nor has any motion or pleading been filed on his behalf; and that, pursuant to Dist. Ct. Rule 10, notice of taking default is not required.

Defendant is in default and has thus admitted the substantial allegations of the Petition. The Court, being fully advised in the premises, and on consideration thereof, finds that the allegations of the Petition are deemed true as therein set

forth and that Plaintiff is entitled to judgment against Defendant for the relief sought in the Petition.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that:

1. Defendant is temporarily and permanently enjoined from transacting business in and/or from this state as an investment adviser.
2. Defendant shall pay restitution to the Investors, as defined in paragraph 15 of the Petition, and all other persons for whom Defendant has transacted business in and/or from this state as an unregistered investment adviser, in amounts to be determined by this Court.
3. Defendant shall pay a civil penalty in the amount of \$20,000 to the Department's Investor Education Revolving Fund.
