
**ORDER APPROVING CONSERVATOR'S REPORT AND

NOW on this 28th day of February, 2014, the application of Conservator, Tom Moran, for entry of an Order approving the interim application for Conservator's fees and expenses for the period of September 1, 2013 through December, 31, 2013, came on for consideration before the undersigned Judge. 


