EXPENSES FOR THE PERIOD OF JUNE 1, 2009 THROUGH JUNE 30, 2009**



IT IS FURTHER ORDERED ADJUDGED AND DECREED that the Conservator's


Report the period of June 1, 2009 through June 30, 2009 is hereby approved.


