ORDER SETTING RESTITUTION

This matter came for hearing before this Court on the 13th day of July, 2018, on Plaintiff's *Motion to Determine Restitution* ("Motion"). No objection to the Motion has been filed. The Court, having reviewed all pleadings and evidence, finds that the Motion is hereby granted. IT IS THEREFORE ORDERED, ADJUGED AND DECREED that:

1. Defendants Secure Operations Group, LLC, Johnnie Louis McAlpine and George Franklin Conner (collectively, the "Defendants") shall be jointly and severally liable to pay restitution to the purchasers of the Sleeper and X Bar Units, as defined in *Plaintiff's Petition for Permanent Injunction and Other Relief*, totaling Three Million Nine Hundred Ninety-One Thousand One

Hundred Forty-Seven Dollars and Twenty-Eight Cents (\$3,991,147.28)(the “Restitution Amount”);

2. Defendants pay the Restitution Amount by cashier’s check to each person and in such amounts as reported in Exhibit A, attached hereto, within 45 days of entry of this Order; and

3. Defendants shall provide the Plaintiff documentation evidencing the payments required in Item No. 2 by mailing a copy of the form of payment to the Oklahoma Department of Securities, 204 North Robinson, Suite 400, Oklahoma City, Oklahoma 73102, within five (5) days of each payment.

IT IS SO ORDERED.


