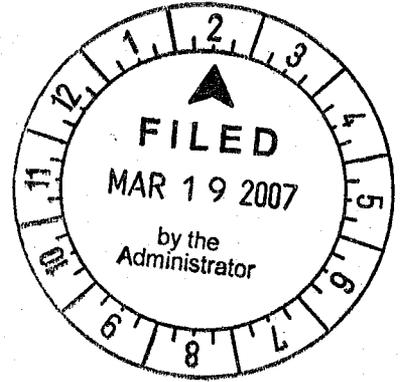

CONSENT ORDER BARRING
FROM ASSOCIATION WITH A BROKER-DEALER AND/OR INVESTMENT
ADVISER AND FROM OFFERING AND/OR SELLING SECURITIES

Pursuant to the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003), and the Oklahoma Securities Act (Predecessor Act), Okla. Stat. tit. 71, §§ 1-413, 501, 701-703 (2001 and Supp. 2003), an investigation was conducted into the activities of Jeffrey Charles Plunkett (Plunkett) to determine whether certain violations of the Act and/or Rules of the Oklahoma Securities Commission and the Administrator of the Department (Rules) may have occurred in connection with the offer and/or sale of securities in and/or from the state of Oklahoma.

For the purpose of resolving the issues raised as a result of the investigation, and without admitting or denying the findings of fact and conclusions of law set forth herein, Plunkett consents to the entry of this order barring him from association with a broker-dealer and or investment adviser and from offering and/or selling securities in and/or from the state of Oklahoma. Plunkett voluntarily waives his right to notice and hearing as required by the Act, the Predecessor Act, and the Oklahoma Administrative Procedures Act, Okla. Stat. tit. 75, §§ 250 *et. seq.*

The Administrator of the Department, being fully advised in this matter, hereby finds that the issuance of this Order is in the public interest and does hereby adopt the Findings of Fact and Conclusions of Law as set forth below.

FINDINGS OF FACT

1. Plunkett was registered under the Act from May 1996, to December 2000, as an agent for various broker-dealers.

2. On December 14, 2000, Plunkett became registered as an agent of Pruco Securities LLC (Pruco). On July 10, 2002, Plunkett became registered under the Act as an investment adviser representative for Pruco. Plunkett's registrations with Pruco terminated on May 11, 2005.

3. Plunkett became registered under the Act as an agent and an investment adviser representative of MML Investors Services, Inc. (MML) on May 13, 2005. Plunkett's registration with MML terminated on November 1, 2005. Plunkett is not currently registered under the Act.

4. During the course of his employment with Pruco, Plunkett misappropriated approximately \$626,000 from two customer accounts without the customers' authorizations.

To the extent any of these Findings of Fact are more properly characterized as Conclusions of Law, they should be so construed.

CONCLUSIONS OF LAW

1. Plunkett engaged in dishonest or unethical practices in the securities business as defined in 660:10-5-42 of the Predecessor Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities and 660:11-5-42 of the Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities.

2. Plunkett, directly or indirectly, employed a device, scheme, or artifice to defraud, in connection with the offer and sale of securities, in violation of Section 101 of the Predecessor Act and Section 1-501 of the Act.

3. Plunkett engaged in an act, practice or course of business that operated as a fraud or deceit in connection with the offer and/or sale of securities, in violation of Section 101 of the Predecessor Act and Section 1-501 of the Act.

4. The Administrator is authorized to impose any sanctions set forth in Section 406 of the Predecessor Act and in Section 1-411 of the Act.

5. It is in the public interest to bar Plunkett from association with a broker-dealer and/or investment adviser in any capacity and from offering and/or selling securities in and/or from the state of Oklahoma.

To the extent any of these Conclusions of Law are more properly characterized as Findings of Fact, they should be so considered.

ORDER

IT IS HEREBY ORDERED THAT Jeffrey Charles Plunkett is barred from association with a broker-dealer and/or investment adviser in any capacity and is barred from offering and/or selling securities in and/or from the state of Oklahoma.

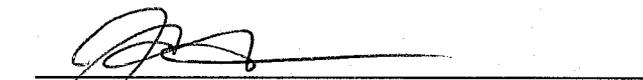
