FINAL ORDER TO CEASE AND DESIST

The Administrator of the Oklahoma Department of Securities ("Department") issues this *Final Order to Cease and Desist* ("Final Order") pursuant to Section 1-604 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011).

On March 31, 2014, the Administrator of the Department ("Administrator"), pursuant to Section 1-604 of the Act, ordered Respondent to immediately cease and desist from offering and selling unregistered securities, making untrue statements and omissions of material fact in connection with the offer and sale of securities, and transacting business as an unregistered agent and/or investment adviser representative, in and/or from Oklahoma, in violation of the Act ("Cease and Desist Order").

Pursuant to Section 1-611 of the Act, service on Respondent was made by serving the Administrator on March 31, 2014. On March 31, 2014, the Administrator provided Respondent with notice of opportunity for hearing as required by Section 1-604 of the Act ("Notice"). The Administrator filed a *Notice of Service on the Administrator and Affidavit of Compliance* ("Service on the Administrator") pursuant to Section 1-611 of the Act, and sent the Cease and Desist Order, Notice and Service on the Administrator (collectively, the "Filings") via certified mail, return receipt requested, delivery restricted, to the Respondent at his last known addresses: 3713 East 28th Street, Tulsa, Oklahoma 74114; and 8421 East 61st Street Suite V, Tulsa, Oklahoma.

On April 8, 2014, the U.S. Postal Service returned the Filings sent to the Respondent at 3713 East 28th Street, Tulsa, Oklahoma 74114 to the Department marked "Return To Sender, Attempted - Not Known, Unable To Forward."

On April 10, 2014, the U.S. Postal Service returned the Filings sent to the Respondent at 8421 East 61st Street Suite V, Tulsa, Oklahoma 74133 to the Department marked "Return To Sender, Attempted - Not Known, Unable To Forward."


To date, the Respondent has not requested a hearing in response to the Filings.
