FINAL ORDER TO CEASE AND DESIST

The Administrator of the Oklahoma Department of Securities ("Department") issues this *Final Order to Cease and Desist* ("Final Order") pursuant to Section 1-604 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011).

On January 22, 2014, the Administrator of the Department ("Administrator"), pursuant to Section 1-604 of the Act, ordered Respondents to immediately cease and desist from engaging in acts, practices or a course of business constituting a violation of the Act ("Cease and Desist Order").

On January 22, 2014, the Administrator notified the Respondents of their obligation to file an answer and their right to request a hearing to show why a final order based on the Cease and Desist Order should not be issued: filed a *Notice of Opportunity for Hearing* ("Notice") pursuant to Section 1-604 of the Act. The Administrator filed a *Notice of Service on the Administrator and Affidavit of Compliance* ("Service on the Administrator") pursuant to Section 1-611 of the Act, and sent the Cease and Desist Order, Notice and Service on the Administrator (collectively, the "Filings") via certified mail, return receipt requested, delivery restricted, to the Respondents.

The Filings sent to the Respondents were signed for on January 24, 2014.


To date, the Respondents have not requested a hearing in response to the Filings.


