FINAL ORDER TO CEASE AND DESIST

The Administrator of the Oklahoma Department of Securities ("Department") issues this *Final Order to Cease and Desist* ("Final Order") pursuant to Section 1-604 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011).

On March 7, 2014, the Administrator of the Department ("Administrator"), pursuant to Section 1-604.A of the Act, ordered Respondents to immediately cease and desist from engaging in acts, practices or a course of business constituting a violation of the Act ("Cease and Desist Order").

On March 7, 2014, the Administrator filed a Notice of Opportunity for Hearing ("Notice") notifying Respondents of their obligation to file an answer and their right to request a hearing to show why a final order based on the Cease and Desist Order should not be issued.

On March 7, 2014, the Administrator filed a *Notice of Service on the Administrator and Affidavit of Compliance* ("Service on the Administrator") pursuant to Section 1-611 of the Act, and sent the Cease and Desist Order, Notice and Service on the Administrator (collectively, the "Filings") via certified mail, return receipt requested, delivery restricted, to the Respondents at their last known addresses: Thomas Cunningham, 2121 Bentley Avenue, Los Angeles, CA 90025; and to Savoy Jewels Inc., 269 South Beverly Drive, #1103, Beverly Hills, CA 90212.

The Filings sent to Savoy Jewels Inc. were signed for on March 12, 2014.

On March 24, 2014, the U.S. Postal Service returned the Filings sent to Thomas Cunningham to the Department marked "Return To Sender, Attempted - Not Known, Unable To Forward."


To date, Respondents have not requested a hearing in response to the Filings.




