FINAL ORDER TO CEASE AND DESIST

Pursuant to Section 1-602 of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2009), the Oklahoma Department of Securities (Department) conducted an investigation into the activities of Construction Management Group (Construction Management), Phillip Troy Stevens, Jr. (Stevens), and Cody J. Fell (Fell) (collectively, "Respondents"), in connection with the offer and/or sale of securities in and/or from the state of Oklahoma.

On April 9, 2010, the Administrator of the Department (Administrator) issued an *Order to Cease and Desist* and *Notice of Opportunity for Hearing* (Order and Notice). Pursuant to Section 1-604 of the Act, the Order and Notice were mailed to Respondents, by certified mail, return receipt requested, and delivery restricted, on April 9, 2010. Pursuant to Section 1-611 of the Act, service on Respondents was made by serving the Administrator on April 9, 2010. No request for hearing has been received by the Administrator.

On April 27, 2010, the Order and Notice mailed to Construction Management was returned and marked "Unclaimed." On April 27, 2010, the Order and Notice mailed to Fell was returned and marked "Unclaimed." On April 30, 2010, the Order and Notice mailed to Stevens was returned and marked "Unclaimed." Further, the Department notified both Fell and Stevens of the Order and Notice during telephone calls that occurred on April 29, 2010.

THEREFORE, pursuant to Section 1-604 of the Act, the cease and desist order issued by the Administrator on April 9, 2010, is final as to Respondents by operation of law.
