**FINAL ORDER TO CEASE AND DESIST**

The Administrator of the Oklahoma Department of Securities ("Department") issues this *Final Order to Cease and Desist* ("Final Order") pursuant to Section 1-604 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011).

On September 17, 2013, the Administrator of the Department ("Administrator"), pursuant to Section 1-604 of the Act, ordered the Respondents to immediately cease and desist from offering and selling unregistered securities, making untrue statements and omissions of material fact in connection with the offer and sale of securities, and transacting business as a broker-dealer, agent, investment adviser, and/or investment adviser representative, in and/or from Oklahoma in violation of the Act ("C&D").

On September 17, 2013, the Administrator, in order to notify the Respondents of their obligation to file an answer and their right to request a hearing to show why a final order based on the C&D should not be issued: filed a *Notice of Opportunity for Hearing* ("Notice") pursuant to Section 1-604 of the Act; filed a *Notice of Service on the Administrator and Affidavit of Compliance* ("Affidavit") pursuant to Section 1-611 of the Act; and sent the C&D, Notice and Affidavit (collectively, the "Filings") via certified mail, return receipt requested, delivery restricted, to the Respondents.

The Filings sent to the Respondents were signed for on September 19, 2013.

On September 19, 2013, the Department received a written letter from the Respondents. The letter confirmed Respondents' receipt of the Filings and stated that they would immediately comply with the C&D.


To date, Respondents have not filed an answer specifically admitting or denying each allegation in the C&D and have not requested a hearing to show why a final order based on the C&D should not be issued.

ORDER

**IT IS HEREBY ORDERED** that, pursuant to Section 1-604 of the Act, the C&D issued on September 17, 2013, is final by operation of law.




