

**FINAL ORDER TO CEASE AND DESIST**

On December 14, 2006, an *Order to Cease and Desist* (Order), and *Notice of Opportunity for Hearing* (Notice for Hearing) were issued against Nu Gospel Records (NGR), Pocket Pay Solutions (Pocket Pay), and DeAngelo C. Spotwood (Spotwood) (collectively "Respondents") by the Administrator of the Oklahoma Department of Securities (Department). The issuance of this Order is authorized by Section 406 of the Oklahoma Securities Act (Predecessor Act), Okla. Stat. tit. 71, §§ 1-413, 501, 701-703 (2001 & Supp. 2003), and Section 1-604 of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003).

On December 14, 2006, the Administrator was served with the Order and the Notice for Hearing pursuant to Section 1-611 of the Act. The Order and the Notice for Hearing were mailed December 15, 2006, to the last known addresses of Respondents, by certified mail, return receipt requested, and delivery restricted. On January 10, 2007, the Order and the Notice for Hearing sent to Pocket Pay and Spotwood at 5513 Shalimar Drive, Oklahoma City, Oklahoma, were returned marked "Returned To Sender, Unclaimed." On January 18, 2007, the Order and the Notice for Hearing sent to NGR at 1821 North Classen Boulevard, Oklahoma City, Oklahoma, was returned marked "Returned To Sender, Unclaimed."

Pursuant to Section 1-604 of the Act, the Notice for Hearing specified that failure to make a written request for hearing would result in the Order becoming final as to Respondents by operation of law. No written request for hearing has been received by the Administrator.

**IT IS HEREBY ORDERED** that the Order to Cease and Desist issued against NGR, Pocket Pay, and Spotwood on December 14, 2006, attached hereto as Exhibit A, is final by operation of law.


