

RESPONDENT NORMAN FRAGER'S JOINDER IN GEARY RESPONDENTS'
MOTIONS AND OBJECTIONS FILED MAY 28, 2011

Pursuant to Rule 660:2-9-3(c) of the Rules of the Oklahoma Department of Securities, Respondent, Norman Frager ("Frager") submits this joinder to the Respondents Geary Securities, Inc. (formerly known as Capital West Securities, Inc.), Keith D. Geary, and CEMP, LLC (the "Geary Respondents") Motions and Objection filed March 28, 2011 requesting that the Hearing Officer:

1. Issue a preclusion order and an order striking certain witnesses listed by the Oklahoma Department of Securities (the "Department") and all allegations contained in the Recommendation relating to such witnesses based upon the Department's failure to produce responsive documents; or alternatively, immediately issue an Order compelling the Department to produce responsive documents it has withheld from production, together with such additional relief as is appropriate; and
2. Issue a preclusion order and an order striking certain witnesses listed by the Oklahoma Department of Securities (the "Department") and all allegations contained in the Recommendation relating to such witnesses based upon the Department's failure to comply with the terms of the Agreed Amended Scheduling Order by failing to provide required witness information; and

3. Sustain the objection to the Department's Amended Final Witness List and request for an order striking certain witnesses listed by the Oklahoma Department of Securities (the "Department") based upon the Department's failure to comply with the terms of the Agreed Amended Scheduling Order by filing an amended final witness list after the expiration of the agreed mandatory deadline.

WHEREFORE, Respondent Frager joins in the motions and objection filed by the Geary Respondents on March 28, 2011 requesting the Hearing Officer issue orders in accordance with their motions.
