**DEPARTMENT'S MOTION FOR PROTECTIVE ORDER REMOVING
MATERIALS FROM PUBLIC RECORD**

Oklahoma Department of Securities ("Department") moves for a protective order removing the following materials from the public record: 1) *Supplemental Response of Norman Frager to Motion by Oklahoma Department of Securities for Summary Decision Against Norman Frager and Motion to Dismiss All Allegations of May 2009 Net Capital Violations* ("Frager's Supplement"), filed on February 27, 2012, including the disc of audio recordings filed therewith, and 2) Exhibits A and B (transcripts of two of the audio recordings contained on the disc filed with Frager's Supplement) to the Department's reply to Frager's Supplement, filed on March 5, 2012. Because they contain references to sensitive information protected by federal law ("Protected Information"), these items should be removed from the public record and the public dissemination of these items or any references to the Protected Information should be prohibited. The issuance of a protective order is authorized by Section 1-607(B) of the Oklahoma Uniform Securities Act of 2004.

Respondents have informed the Department that they do not object to this motion. All parties have approved the proposed Order submitted with this motion.
