**DEPARTMENT'S UNOPPOSED MOTION FOR EXTENSION OF TIME TO REPLY TO
RESPONSE OF RESPONDENT FRAGER TO DEPARTMENT'S MOTION FOR
RECONSIDERATION ON MOTION FOR SUMMARY DECISION AND RESPOND TO
RESPONDENT FRAGER'S CROSS MOTION FOR SUMMARY DECISION**

The Oklahoma Department of Securities ("Department") respectfully requests that the Hearing Officer enter an Order extending the deadline for the Department to file (1) its reply to the response of Respondent Norman Frager ("Frager") to the Department's Motion for Reconsideration on Motion for Summary Decision ("Department's Motion to Reconsider") and (2) its response to Frager's cross motion for summary decision ("Frager's MSD"), to Tuesday, August 14, 2012. The Department states the following in support of its request:

1. Frager's response to the Department's Motion to Reconsider and Frager's MSD were filed together as one document, without differentiation, on July 31, 2012.
2. The Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities ("Rules") do not provide a deadline for the filing of a reply to Frager's response to the Department's Motion to Reconsider.

3. Under the Rules, the Department's response to Frager's MSD is due on Friday, August 10, 2012.
4. Because there is no differentiation in the filed document between Frager's response to the Department's Motion to Reconsider and Frager's MSD, the Department anticipates having to combine the relevant reply and response into one document.
5. The Department expects to need an additional affidavit to respond to Frager's MSD and will need time to obtain it.
6. The Department requests until Tuesday, August 14, 2012, to reply to Frager's response to the Department's Motion to Reconsider and to respond to Frager's MSD.
7. Respondent Frager has consented to the requested extension.

Based on the foregoing, the Department respectfully requests that the Hearing Officer issue an Order extending its time to reply to Frager's response to the Department's Motion to Reconsider and to respond to Frager's MSD to August 14, 2012.
