**ORDER INITIATING PUBLIC INVESTIGATION**

It has come to the attention of the Administrator of the Oklahoma Department of Securities ("Department") that violations of certain provisions of the Oklahoma Business Opportunity Sales Act ("Act"), Okla. Stat. tit. 71, §§ 801 through 829 (2011), and/or the Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities ("Rules"), may have occurred, may be occurring, or may be about to occur in connection with the offer and/or sale of business opportunities by Manna Source Sustainable, LLC, Jerrold Wayne Myers, and Gary Douglas Warlick.

Section 813 of the Act provides in part:

A. The Administrator:

1. May make such public or private investigations within or outside of this state as the Administrator deems necessary to determine whether any person has violated or is about to violate any provision of the Oklahoma Business Opportunity Sales Act or any rule or order hereunder, or to aid in the enforcement of the act or in the prescribing of rules and forms hereunder;
2. May require or permit any person to file a statement, under oath or otherwise as the Administrator determines, as to all the facts and circumstances concerning the matter to be investigated; and
3. May publish information concerning any violation of the Oklahoma Business Opportunity Sales Act or any rule or order hereunder.

- B. For the purpose of any investigation or proceeding pursuant to the Oklahoma Business Opportunity Sales Act, the Administrator or the Administrator's designee may administer oaths and affirmations, subpoena witnesses, compel their attendance, take evidence and require the production of any books, paper, correspondence, memoranda, agreements or other documents or records which the Administrator deems relevant or material to the inquiry.


Based upon the information received and in light of the provisions of the Act, the Administrator has determined it to be in the public interest to conduct a public investigation into the activities of Manna Source Sustainable, LLC, Jerrold Wayne Myers, and Gary Douglas Warlick.

**IT IS THEREFORE ORDERED** that a public investigation be commenced by the Department into the activities of Manna Source Sustainable, LLC, Jerrold Wayne Myers, and Gary Douglas Warlick, and associated or affiliated entities or individuals, to determine whether such persons have violated or are about to violate any provision of the Act and/or the Rules.

If the Administrator determines that violations of the Act and/or the Rules have occurred, the Administrator may pursue any of the courses of action set forth in the Act or as otherwise authorized by law. If, however, the facts indicate that no corrective action by the Administrator is warranted, the investigation will be closed.
