**ORDER APPROVING REPORT OF RECEIVER REGARDING

Comes on for hearing on this 2nd day of May, 2006 on the Report of Receiver, Stephen J. Moriarty Regarding Accounting and Proposed Distribution, filed on March 29, 2006 (the "Report"); Receiver, Stephen J. Moriarty appearing *pro se* and Patricia A. Labarthe appearing on behalf of the Oklahoma Department of Securities. After having heard arguments of counsel, and there being no objections to the Report, the Court finds:

1. On January 31, 2006 this Court entered an Order Establishing Procedure to Notify Claimants to File Claims. Pursuant to the Order, Receiver mailed to all known creditors a copy of the Court's Order establishing a bar date of March 17, 2006 and a form

Proof of Claim. Receiver also published notice of the Bar Date in the Shawnee News-Star on February 14, 2006 and February 21, 2006.

2. The Report, and notice of this hearing, was mailed to all known creditors on or before March 30, 2006.

3. No written objections to the Report have been filed with the Court.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Report of Receiver, Stephen J. Moriarty Regarding Accounting and Proposed Distribution is hereby approved.
