**ORDER DENYING RESPONDENTS'
MOTION FOR SUMMARY DISPOSITION AND
DEPARTMENT'S MOTION FOR SUMMARY DECISION**

On December 2, 2013, Respondents Rodney Larry Watkins, Jr. ("Watkins") and Southeast Investments, N.C. Inc. ("Southeast") filed a motion with the Administrator ("Administrator") of the Oklahoma Department of Securities ("Department"), requesting the Administrator to dismiss the referenced matter or summarily dispose of same. On February 28, 2014, the Department filed its motion for summary decision in the referenced matter.


Pursuant to 660:2-9-3(d) of the Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities, the Administrator may issue a summary decision if he finds that there is no genuine issue as to any material fact and that the moving party is entitled to prevail as a matter of law. However, from a reading of the allegations within each of the subject motions, the location of Respondent Watkins during some or all aspects of the subject transactions is in dispute. Section 1-610 of the Oklahoma Uniform Securities Act of 2004 ("Act") sets forth the activities that establish jurisdiction under the Act, and location is a material fact for such determinations.

THEREFORE, IT IS HEREBY ORDERED that Respondents' Motion for Summary Disposition is denied.

FURTHER, IT IS HEREBY ORDERED that the Department's Motion for Summary Decision is denied.


