ORDER FOR RETURN OF INVESTOR ASSETS

This matter came on for hearing this 6 day of October, 2005,  
before the undersigned Judge of the District Court in and for Pottawatomie County, State of  
Oklahoma, upon the First Amendment to Petition for Permanent Injunction and Other Equitable  
Relief ("First Amendment") against Relief Defendant Sandra Friguletto ("Sandra Friguletto")  
pursuant to Section 406.1 of the Oklahoma Securities Act, Okla. Stat. Ann. tit. 71, §§ 1-413, 501,  
701-703 (West 2004).

After a review of the pleadings and evidence, this Court finds:

1. In October, 2002, Sandra Friguletto received funds from The Hickman Agency, Inc. and Merl William Hickman, Sr. ("Defendants"), that were the proceeds, or were traceable to the proceeds, of the unlawful activities of Defendants, (collectively, "Investor Assets"), as alleged in the First Amendment and in Paragraphs 1 through 29 of the Petition for Permanent Injunction and Other Equitable Relief.

2. It is not just, equitable or conscionable for Sandra Friguletto to retain the Investor Assets.

3. Sandra Friguletto has executed a Stipulation and Consent to Order For Return of Investor Assets ("Stipulation and Consent") that is incorporated herein by reference.

IT IS HEREBY ORDERED that Sandra Friguletto pay to the Receiver, Stephen J. Moriarty ("Receiver"), the sum of Fourteen Thousand Dollars (\$14,000.00), for restitution to investors as follows:

- a. Payment of the sum of Five Thousand Dollars (\$5,000.00), to the Receiver, upon execution of the Stipulation and Consent; and
- b. Payment of the sum of Nine Thousand Dollars (\$9,000.00), to the Receiver, on or before December 1, 2005.

IT IS FURTHER ORDERED that the Oklahoma Department of Securities dismiss with prejudice, its case against Sandra Friguletto, upon receipt of the payment of restitution by Sandra Friguletto as ordered herein.

IT IS FURTHER ORDERED that this Court will retain jurisdiction of this matter for the purpose of enforcement of this order.
