

**ORDER GRANTING MOTION OF RESPONDENT NORMAN FRAGER TO  
CONTINUE HEARING**

This matter having come before the Hearing Officer on the Motion of Respondent Norman Frager to Continue Hearing, and having considered said motion, it is determined as follows:

1. On May 17, 2012, the Hearing Officer entered a Final Amended Scheduling Order setting a hearing on the merits to commence on June 18, 2012.
2. On May 25, 2012, Respondent Frager filed a Motion to Continue Hearing requesting a sixty day continuance of the hearing on the merits.
3. On May 31, 2012 Respondent Frager filed a Supplement to Motion of Norman Frager to Continue Hearing (the "Supplement") stating certain medical issues concerning Respondent's spouse as additional grounds for granting said continuance.
4. Regarding the grounds for granting the continuance as stated by Respondent in the May 25<sup>th</sup> motion, the Hearing Officer finds that such issues will be resolved by other motions ruled on by the Hearing Officer contemporaneously with this Order.
5. The Hearing Officer further finds that the medical issues as stated by the Respondent in the Supplement justify the granting of a continuance of the hearing on the merits.
6. The Department of Securities has concurred in granting the motion for continuance on the medical grounds stated by Respondent in the Supplement.

Therefore, it is ORDERED that the hearing on the merits scheduled to commence on June 18, 2012 is hereby continued, with a new date to be set in a subsequent Scheduling Order.

The parties are further ORDERED to promptly confer about an appropriate date for the hearing to be in August, 2012, and to notify the Hearing Officer of the available date.


