IT IS ORDERED HEREBY that any discovery issues not completed or resolved by the parties shall be presented at a hearing on April 30, 2014 at 10:00 a.m. in the offices of the Oklahoma Department of Securities, First National Center, Suite 860, 120 North Robinson Avenue, Oklahoma City, Oklahoma.


