ORDER REVOKING REGISTRATIONS

Pursuant to Section 1-410 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011), the Examinations Division of the Oklahoma Department of Securities ("Department") conducted an examination into the activities of John Johanning, Inc. and John Arnold Johanning (collectively, the "Respondents").

On September 24, 2012, the Enforcement Division filed a *Recommendation to Revoke Registrations and Notice of Opportunity for Hearing (Recommendation and Notice)* against Respondents. Pursuant to Section 1-611 of the Act, service of the *Recommendation and Notice* upon Respondents was effected by service on the Administrator on September 26, 2012. The *Recommendation and Notice* were mailed to Respondents at their last known addresses, by certified mail, return receipt requested, and delivery restricted, on September 24, 2012. The return receipt was signed by Regina Copeland on behalf of John Johanning, Inc. on September 26, 2012. On October 19, 2012, the Notice mailed to Respondent John Arnold Johanning was returned to the Department marked "Return To Sender, Attempted - Not Known, Unable To Forward."


No request for hearing has been received by the Administrator.
