**ORDER SETTING HEARING AND APPOINTING HEARING OFFICER**

**WHEREAS**, on September 22, 2010, the Enforcement Division submitted to the Administrator of the Oklahoma Department of Securities ("Administrator") its recommendation ("Recommendation") for an order sanctioning Geary Securities, Inc. *fka* Capital West Securities, Inc.; Keith D. Geary; Norman Frager; and CEMP, LLC, (collectively "Respondents"), in connection with the purchase, offer and/or sale of securities in and/or from the state of Oklahoma in violation of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2009), and the Rules of the Oklahoma Securities Commission and the Administrator of the Oklahoma Department of Securities ("Rules").

**WHEREAS**, on September 22, 2010, the Administrator issued to Respondents a Notice of Opportunity for Hearing ("Notice") and a Notice of Service on the Administrator and Affidavit of Compliance ("Affidavit").

**WHEREAS**, on September 22, 2010, a copy of the Notice with a copy of the Recommendation attached was sent by certified mail, return receipt requested, delivery restricted to addressee, to the last known address of Respondents, in compliance with Section 1-611 of the Act.

**WHEREAS**, Respondents requested an extension of time to October 15, 2010, to file their answers and to request a hearing. Such request was granted.

**WHEREAS**, on October 15, 2010, Respondents filed their answers and requested a hearing.



the opportunity to show cause why an order should not be issued, shall commence at **10:00 a.m.** on **February 23, 2011**, in the offices of the Oklahoma Department of Securities, First National Center, Suite 860, 120 North Robinson Avenue, Oklahoma City, Oklahoma.

**IT IS FURTHER HEREBY ORDERED** that Bruce Kohl of Santa Fe, New Mexico, is designated and appointed as hearing officer to conduct the individual proceeding in this matter and to make a recommendation to the Administrator based upon the evidence and legal authority presented.


