

ORDER VACATING ORDER BARRING FROM ASSOCIATION WITH A BROKER-DEALER AND/OR INVESTMENT ADVISER

On October 23, 2006, the Administrator of the Oklahoma Department of Securities (Administrator) issued a *Notice of Opportunity for Hearing* (Notice), with an *Enforcement Division Recommendation* (Recommendation) attached. On October 23, 2006, a copy of the Notice with the Recommendation attached, and a *Notice of Service on the Administrator and Affidavit of Compliance* was sent by certified mail, return receipt requested, delivery restricted to addressee, to 126 E. 124th Street, Jenks, Oklahoma (Jenks Address), the last known address of Michael E. Hentges (Hentges), in compliance with Section 1-611 of the Act.

On October 25, 2006, the United States Postal Service (USPS) attempted to deliver the certified mail to Hentges. USPS left a notice at the Jenks Address advising that the certified mail could be redelivered or picked up at the designated post office. On November 28, 2006, the certified mail was returned to the Department marked "Returned To Sender, Unclaimed." Hentges did not request a hearing.

On December 14, 2006, the Administrator issued an *Order Barring from Association with a Broker-Dealer and/or Investment Adviser* (Final Order) against Hentges as required by statute. The Final Order was sent to Hentges by certified mail to the Jenks Address. On December 18, 2006, Hentges signed for the receipt of the Final Order.

On December 26, 2006, the Department was notified by counsel for Hentges that Hentges no longer resides at 126 E. 124th Street, Jenks, Oklahoma, and that Hentges had not received the Administrator's Notice with the Recommendation attached. Further, a courtesy copy of the Notice with the Recommendation attached had not been sent to counsel for Hentges.

IT IS THEREFORE ORDERED that the Final Order entered on December 14, 2006, in the above styled and numbered administrative proceeding is hereby vacated.


