(3) This matter is currently set for Hearing on June 17, 1999 at 9:00 a.m. for scheduling deadlines/trial date.


Therefore, the Court, having considered the Motion of Pray, Walker, Jackman, Williamson & Marljar to Withdraw as Attorneys of




