Upon the Joint Application for Continuance of Hearing and Application for Extension of Answer and Response Dates filed by the Oklahoma Department of Securities ("Department") and Renaissance U.S.A., Inc. ("Renaissance"), and for good cause shown, it is hereby ordered that (i) the hearing on the Temporary Restraining Order and Preliminary Injunction as to those parties only is continued until May 1, 1998; (ii) that this Court's Temporary Restraining Order entered January 16, 1998, is continued in full force and effect until such hearing is concluded or this matter resolved; (iii) that Renaissance has until April 17, 1998, in which to file its answer or other response to the Department's Petition for Permanent Injunction and Other Equitable Relief, and to file its response to the Department's Combined Motion for Temporary Restraining Order and Temporary Injunction and Brief in Support; and (iv) that the Department is to file its reply on or before April 24, 1998.




