MOTION FOR DEFAULT JUDGMENT

The Oklahoma Department of Securities *ex rel.* Melanie Hall, Administrator (the "Plaintiff"), moves this Court to issue judgment by default, in the form attached hereto, in its favor and against Defendant Nathaniel F. Rogers. In support of this motion, Plaintiff states as follows:

1. On August 9, 2020, Defendant Nathaniel F. Rogers was served with Plaintiff's *Petition for Permanent Injunction and Other Relief* (the "Petition") and summons by personal process server.
2. In accordance with 12 O.S. §§ 2012 and 2006, Defendant was required to appear and defend this action no later than August 31, 2020.

3. As of the filing of this Motion, Defendant Nathaniel F. Rogers has failed to appear, answer or otherwise plead, and his time for doing so has expired.
4. In accordance with Dist. Ct. Rule 10 and due to Defendant Nathaniel F. Rogers' failure to appear, notice of taking default is not required and such notice has not been sent to him.

WHEREFORE, premises considered, Plaintiff prays that judgment by default be entered in its favor and against Defendant Nathaniel F. Rogers as outlined in its Petition.

JUDGMENT

This action came before the Court on the motion of the Oklahoma Department of Securities *ex rel.* Melanie Hall, Administrator (the “Plaintiff”), for default judgment against Defendant Nathaniel F. Rogers.

The Court, having reviewed the Plaintiff’s *Petition for Permanent Injunction and Other Relief* (the “Petition”), summons, return of service and court file, finds that Defendant Nathaniel F. Rogers has been validly served with the Petition and summons; that the date by which Defendant Nathaniel F. Rogers was required to appear and defend this action was August 31, 2020; that no appearance has been made by Defendant Nathaniel F. Rogers; that no motion or pleading has been filed on his behalf; and that, pursuant to Dist. Ct. Rule 10, notice of taking default is not

required.


The Court, being fully advised in the premises, and on consideration thereof, finds that Defendant Nathaniel F. Rogers is in default and that Plaintiff is entitled to judgment against Defendant Nathaniel F. Rogers.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Defendant Nathaniel F. Rogers – and any entity he owns and/or controls – is permanently enjoined from transacting business in and/or from Oklahoma as an issuer, issuer agent, broker-dealer, or broker-dealer agent and otherwise offering or selling securities in and/or from Oklahoma.
