ORDER AUTHORIZING SIXTH INTERIM APPLICATION BY ERIC L. JOHNSON, RECEIVER, FOR ALLOWANCE OF COMPENSATION FOR SERVICES RENDERED AND REIMBURSEMENT OF ACTUAL AND NECESSARY EXPENSES FOR THE PERIOD OF APRIL 1, 2024 THROUGH SEPTEMBER 30, 2024

NOW on this 5th day of December 2024, the duly appointed Receiver, Eric L. Johnson's (the "Receiver") *Sixth Interim Application for Allowance of Compensation for Services Rendered and Reimbursement of Actual and Necessary Expenses for the Period of April 1, 2024 through September 30, 2024* (the "Application") comes before the Court, and after appropriate notice and opportunity for a hearing, with no objections filed by the objection deadline; and for good cause shown:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

1. The Application is granted.
2. The Sixth Interim Fees are allowed in the following amounts: (a) \$101,009.00 in fees for the Receiver; (b) \$353,109.98 in legal fees and expenses for Spencer Fane; (c) \$35,645.40

in expenses for BRG; and (d) \$6473.75-in fees and expenses for McKoy Torres.¹

3. The payments already made or authorized to be made pursuant to the monthly compensation procedures are hereby ratified and/or further authorized to be paid.

4. The Receiver and his professionals are authorized to pay and/or apply the 20% holdback of the Sixth Interim Fees in the total amount of \$90,160.45 that have been incurred but not yet paid (the "Holdback Amounts").

5. The McKoy Torres' fees and expenses identified in the Invoices in the amount of \$45,190.58 are approved, and the Court ratifies any draws against the retainers that have been previously made.

6. The Court authorizes to maintain a retainer with McCoy Torres in the amount of \$25,000.


