JOURNAL ENTRY

NOW on January 14, 2026, Plaintiff's *Motion to Compel Discovery from Defendants* came on for hearing before the Court. Plaintiff, Oklahoma Department of Securities, appeared by and through its counsel of record in the case, Bradley E. Davenport, Robert E. Fagnant, and Maddison M. Bacon. Defendants, Cool Blue Capital, LLC, Cool Blue Capital Management, LLC, Charles Brent Orr, and Ryan Shay, appeared by and through their counsel of record, John T. Richer.

Based on the briefs and argument of counsel, the court finds that Plaintiff's motion should be granted in part and denied in part.

IT IS THEREFORE ORDERED, ADJUDGED, and DECREED that Plaintiff's *Motion to Compel Discovery from Defendants* is *GRANTED*, in part, and *DENIED*, in part, as follows:

(1) Plaintiff's First Set of Interrogatories and Requests for Production served on September 4, 2025, on each of the Defendants are deemed withdrawn.

(2) Defendants shall respond to Plaintiff's revised Interrogatories and Requests for Production within thirty (30) days service of the same, including interrogatories and requests for production of documents relating to Defendants' asserted affirmative defenses;

(3) Plaintiff's revised discovery requests to Defendants shall initially be reduced to sixty (60) interrogatories and sixty (60) requests for production and jointly reissued to Defendants. The Court's order reducing the initial number of interrogatories and requests for production to Defendants is without prejudice to Plaintiff's right to subsequently issue additional interrogatories and requests for production to Defendants pursuant to, and in accordance with, 12 O.S. § 3226(B)(2)(a); and


(4) Within a reasonable time after responding to Plaintiff's revised interrogatories and requests for production of documents to Defendants and taking of depositions tentatively planned for late January and February, 2026, Defendants shall streamline and narrow their affirmative defenses asserted in this matter and amend their answers accordingly.

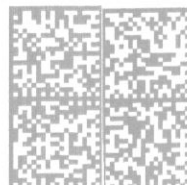

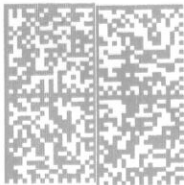
